NOTICE IS HEREBY GIVEN that, pursuant to a resolution adopted by the Board of Fire Commissioners of the Commack Fire District on April 20, 2022, a Special Election of the qualified voters of said Fire District will be held at the Commack Firehouse located at 6309 Jericho Turnpike, Commack, New York on June 14, 2022, between the hours of 6:00 PM and 9:00 PM (prevailing time) for the purpose of enabling said qualified voters to cast their votes upon the following Proposition:

PROPOSITION

SHALL the resolution of the Commack Fire District, adopted by the Board of Fire Commissioners of said District on April 20, 2022, pursuant to the provisions of the Town Law of the State of New York, which resolution provides that the following described vehicle be sold as surplus property, no longer necessary for any of the uses or purposes of the Commack Fire District, and further that the vehicle is valued at more than \$100,000.00: 2009 100' Spartan Tower Ladder, BE APPROVED?

All residents of the Fire District who shall have resided in the Fire District for the period of thirty days next preceding the day of the Special Election and who were duly registered with the Suffolk County Board of Elections on or before 23 days prior to the date of the Special Election shall be eligible to vote at said Special Election.

Please be advised that the Board of Elections of the Fire District shall meet on May 31, 2022 at 1:00 PM at the Fire District office for the purpose of preparing the rolls of the registered voters of the Fire District.
