Driveway Apron Permit: Residential	\$150.00 per apron/ Commercial \$200 per apron
Bell Hole Excavation up to 50 sq. ft.	\$150.00 each
Bell Hole excavation greater than 50 sq. ft.	\$250.00 each
Directional Drill	\$150.00 for 1 st 100 ft., \$1.00 ft. thereafter
Test Hole/Monitoring Well	\$200.00 each
Excavation up to 60" depth	\$150.00 for 1 st 100 ft., \$1.00 ft. thereafter
Excavation greater than 60" depth	\$175.00 for 1 st 100 ft., \$1.00 ft. thereafter
Sidewalk excavation	\$150.00 for 1 st 100 ft., \$1.00 ft. thereafter
Curb or Curb Cut & Sidewalk Excavation	\$150.00 for 1 st 100 ft., \$1.00 ft. thereafter
Communication/Utility Pole Install or Replacement	\$150.00 per pole (If a pole is double, a \$1,000 bond will be required. Bond returned when double pole is removed.)
Emergency Processing Surcharge (Utilities only)	\$50.00 for less than 48 hours notice

Any permits requiring additional final inspections will be charged reinspection fees (see above). Road Opening Permits: PLEASE NOTE: Permits expire on date listed on permit. If you have not called for your inspections by the expiration date, the permit is null and void and all fees are forfeited. ALL APPLICATIONS MUST HAVE CONTACT NAME, PHONE NUMBER AND EMAIL ADDRESS ON THEM. All permits and receipts will be sent electronically.
